Tennessee Walking Horse Breeders' & Exhibitor's Association Lease Registration:

1. TWHBEA requires all lessors of Tennessee Walking Horses competing in competitions and exhibitions to register the lease with TWHBEA. A recorded horse must be shown under a lessee's ownership when an official lease is registered with TWHBEA, the official breed registry. The lessee shall be deemed to be the "owner" of the horse during the term of the lease for purposes of the HPA, but in no event may the lessee sell, transfer or impact in any way with the official owner's legal rights and title to the horse.
2. For points to count with respect to any recorded horse at industry competitions such agreement or lease registration form (provided by TWHBEA) and fees must be received by TWHBEA on or before the first day of such competition.
3. To be official, a certified copy of the TWHBEA lease registration form must be submitted and registered with TWHBEA and must be accompanied by the required fee. The TWHBEA Lease Registration Form, which lists the fee, can be found at **www.twhbea.com**. The document must contain a start and end date and be signed by the lessee and the lessor. It is the responsibility of the lessor/owner to renew the recorded lease. If a lease is not renewed within 30 days of its expiration, a late renewal will require an additional fee. The lease registration with TWHBEA will be effective the date the renewal is received by the TWHBEA office. Lease will expire one year from effective date unless otherwise specified.
4. A written statement of termination must be submitted signed by the lessee and the lessor if the lease is terminated before the end date stated in the lease registration form.
5. Lessee(s) and Lessor must be current members of TWHBEA
6. TWHBEA does not accept agent signatures
